



In relation to the Regulation of the European Parliament and of the Council (EU) 2016/679 of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC, applicable from 25 May 2018, i.e. General Data Protection Regulation, we hereby inform that:

I. Information for natural persons who are Pure Ice contractors:

 - 6) The recipients of the personal data shall be:
- a) employees to whom the data is made available for the implementation of the cooperation; b)service providers rendering services on behalf of or for the Personal Data Controller obligated to comply with the personal data protection provisions;
- c) other entities or public authorities, shall the obligation to disclose the personal data arise from the law provisions.
- 7) Any person, to the extent arising from the law provisions, has the right to access, rectify, limit the processing, object to the processing of its personal data, as well as to transfer the data and withdraw
- the consent at any time. The withdrawal of consent shall not affect the legality of the processing that has been performed on the basis of the consent prior to its withdrawal.
- 8) In doubts related to the processing of personal data, each person may request further information from Pure Ice. Notwithstanding the above, each person has the right to lodge a complaint to the supervisory authority the President of the National Data Protection Authority.
